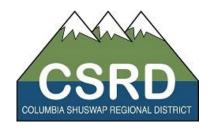

5. Reports by Municipal Directors

5.1 Grant-in-Aid/Corporate Sponsorship

Request by Director Moss.

Director Moss asked how other municipalities approach Grant-in-Aid (GIA) requests and how each municipality works in conjunction with the regional district for GIA. The Town of Golden no longer offers GIA funding and switched to a sponsorship model administered by the mayor and CAO, removing any perceived political benefit.

Director Rysz advised the District of Sicamous budgets funding to Shuswap Community Foundation (SCF) and they are responsible for the adjudication and disbursement the funds. SCF receives a small percentage of the budgeted funds for managing the service. The District of Sicamous is satisfied with this arms-length model.

Director Lavery commented that like the District of Sicamous, City of Salmon Arm also provides budgeted funds in the amount of \$55,000 to SCF. A smaller amount of discretionary funding is available for Council initiatives or groups that may not qualify as non-profit.

Chair stated the City of Revelstoke budgets \$25,000 for GIA funding. Applications are submitted and a committee reviews and disperses most of the funds once per year to non-profit groups. A small amount of the budgeted funds is held aside for emergency type request that arise throughout the year.

CAO commented that from a regional district view, funding can be a very divisive issue and raises the question to financial responsibility. Certainly, at times GIA funding can be perceived as circumventing the service establish process if the same user groups are asking for operational funding annually.

Director Lavery asked how GIA differs regional district to regional district.

CAO advised that some regional districts have little to no GIA funds available. Policy F-30 that sets out the GIA program for the CSRD.

Director Rysz asked how much GIA funding each of the Electoral Areas receive. CAO answered that the GIA funding amount is based on the Electoral Area tax assessment amounts. A break down of GIA funding to Electoral Areas can be found on the 2021 budget.

Director Moss was pleased with the comprehensive discussion and noted that he was not looking for any action from this conversation, he simply wanted to be better informed when making decisions at the Board table.

5.2 Municipal Visitor Services/Tourism

Request by Director Lavery.

Discussion regarding municipal visitor services/tourism models brought forward from March 17 Committee meeting.

Director Lavery stated that the City of Salmon Arm recently made a switch to their visitor services strategy by moving from a contracted third party service to an in-house model.

Chair mentioned City of Revelstoke visitor services are run by the Chamber of Commerce. Direction is received from various boards and committees and recommendations are submitted to City Council for approval and spending authorization.

Director Rysz had been intrigued by the Town of Golden model for some time. Currently the Sicamous Chamber of Commerce manage the visitor services for the District of Sicamous.

Director Moss advised of the success with the current model. Tourism Golden is a non-profit group that is funded through hotel tax. The group is well run and has significantly increased positive exposure to the area and has excelled at creating a good community partnership base. Tourism Golden and economic development work hand in hand but are separate; Town of Golden is arms-length and has very little to do with tourism.

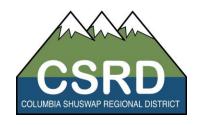

MUNICIPAL DIRECTORS' COMMITTEE

Terms of Reference

1.0 Overview

The Chair of the Board of Directors (the 'Board Chair') for the Columbia-Shuswap Regional District has established the Municipal Directors' Committee (the 'Committee') to provide advice and guidance to the Regional Board concerning matters for which a unique municipal interest has been identified. In accordance with the *Local Government Act*, the Committee shall continue to exist during the term of or until terminated by the Board Chair.

2.0 Purpose and Mandate

- 2.1 The mandate of the Committee is to provide advice and recommendations to the Regional Board concerning matters which:
 - are deemed to be of interest primarily to member municipalities;
 - have been referred to the Committee by the Regional Board;
 - have been referred to the Committee in accordance with Regional District policy; or,
 - are related to the assumption of additional advisory responsibilities which the Committee believe should fall within the Committee's mandate.
- 2.2 The Committee may also make decisions on matters that corporate authority has been specifically delegated by the Regional Board.

3.0 Membership

- 3.1 Membership on the Committee shall be comprised of all Municipal Directors.
- 3.2 The Committee will elect a Chair (the 'Committee Chair') and Vice Chair at its inaugural meeting each year.
- 3.3 The Committee Chair will serve in that capacity until the next inaugural meeting unless the Committee Chair ceases to hold the qualifications for the position.

4.0 Meetings

- 4.1 The Committee will meet as required to fulfill its mandate, up to four (4) times a year.
- 4.2 Meetings will be scheduled in advance by resolution of the Regional Board at its inaugural meeting.
- 4.3 The Committee will be subject to the Regional Board's Procedure Bylaw.

5.0 Reporting

The Committee will provide its advice and recommendations to the Regional Board through receipt and endorsement of the committee meeting minutes, or in the form of a written report from the Committee Chair.
