This project is operational in nature and we will be carrying forward with the customer engagement [as] described in [the] initial email: 'In July 2023, customers affected will be notified of the change and will be provided with details of their new postal code and the implementation date. We understand that this change may cause some inconvenience for residents, but we assure you that it is a necessary step to improve the efficiency and effectiveness of out postal services. Canada Post will also provide customers with 12 months of free mail forwarding to ensure a smooth transition. We believe that this project will not only benefit our residents but also improve the overall mail delivery experience in the area.'
