10.1 Electoral Area A: Golden and Area Economic Opportunity Fund

Under the authority of the Local Government Act - Regional District Special Voting Regulation, Section 2 (1) the following motion was voted on and unanimously carried by the Board of Directors on June 26, 2023:

THAT: with the concurrence of the Town of Golden and Electoral Area A Director, the Board approve funding from the Golden and Area Economic Opportunity Fund to the Town of Golden in the amount of \$657,000 to be applied toward the milling and repaving of the Golden Municipal Airport runway.
