5. Business General

5.1 Shuswap Tourism Budget 9% Budget Implications

Report from Morgen Matheson, Manager, Tourism and Film dated January 31, 2024. Review of Shuswap Tourism 2024 Budget

General Manager, Financial Services spoke to the report and noted that Tourism staff suggested various options to reduce the tax component, and the revised budget removed transfers to operating reserve funds and reduced sponsorships by half.

The General Manager, Financial Services explained the goals of the presentation were to understand the changes from Draft 1, tax implications, answer questions, and provide input for final budget.

Draft 1 changes occurred from: finalized surpluses and deficits, contributions to and from reserves, one-on-one meetings with Electoral Area Directors, and changes suggested from the Draft 1 budget meeting.

Surpluses and Deficits Finalized:

The 2023 net surplus was \$817,000 and the prior year was \$1.5M, which equates to less funds available to put into operating reserves/mitigate taxes. Twenty functions were using surplus funds in 2024 to mitigate taxes or to complete projects carried forward.

The 2023 deficit was \$332,000, which must be repaid in the following tax year as per legislation. The largest was the Scotch Creek water treatment plant where the grant only funds 73% of construction; however, the CSRD did not draw down on the debt as most invoices came in late in the year. As a result, the deficit would be funded by temporary borrowing until debt was drawdown. There was a total of 9 functions with deficits in 2023, up from 2 functions in 2022.

Reserve contributions finalized:

Interest earned on reserve funds was up \$700,000 due to interest rates and capital reserves were approximately \$22M.

Operating reserves totaled approximately \$9.6M which was an increase of \$943,000 from 2023. In 2024 almost \$200,000 in operating reserve would be used to mitigate/stabilize taxes.

Overview of Specific Budget Changes from Draft 1:

The General Manager, Financial Services presented the specific budget changes from Draft 1 to Draft 2 by department and identified the changes to both taxation and overall budget. Significant changes included:

- Shuswap North Okanagan Rail Trail: reduced transfer to operating reserve, reallocated staff time, reduced trail maintenance for section to be activated later in the year. The maintenance standard approved by the Board in 2023 was reviewed and staff anticipate by 2026 costs would begin to level out and the tax requisition would stabilize at approximately \$550,000.
- The taxation and funding for the Shuswap Watershed Council was removed as a result of the failed assent vote.
- There was an overall increase to the general administration budget due to projects being carried forward, but a decrease in taxation as surplus was carried forward. The Electoral Area taxes were down due to the removal of a 1.0 FTE and the new 1.0 FTE communications position to be implemented mid-year. Directors'

remuneration increased for the Keeping it Rural conference attendance and Electoral Area G Grant-in-Aid was increased by \$30,000 at the Director's request.

- Funding for the Recycling function decreased with the removal of a project funded out of capital and changes based on 2023 actuals. Solid Waste Closure Reserve contribution was reduced to \$300,000 in Year 1 with a further increase by \$300,000 per year over next 5 years.
- Supported by the Area Director, funding for the North Shuswap First Responders was increased by \$4,000. The Electoral Area D Community Halls budget was increased by \$9,800 at the Director's request.
- The Area E Parks deficit was eliminated. At the request of the Area Directors the Area C parks reduced the contribution to reserves and Area D parks reduced use of reserves in favour of increasing taxes. Information from the Town of Golden was received and incorporated for Draft 2. Reallocation of Sicamous Arena staff time was applied for tax reduction.
- The Area B fire service operating reserves exceed policy; therefore, reserves were used to reduce the tax requisition. The new tender for the Nicholson firehall (Area A) was \$28,000 over the anticipated cost and capital reserves were used which resulted in no change to taxation. There was a small deficit to the Area E fire service after cost share information was received from District of Sicamous.
- There was a deficit in the 911 service funds, partially due to a Telus lease that had not been billed to the CSRD for a few years and the inclusion of the lease costs going forward.
- The parcel tax fee was removed for the Scotch Creek Water Treatment Plant as the facility has not been established and the bylaw not been adopted. The parcel tax review resulted in some new folios which generated extra tax revenue. The MacArthur-Reedman Water system increased by 10 per cent parcel tax to fund capital reserves at the Director's request.

Incorporating the changes to the budget the overall budget increase was \$80.5M; however, overall taxes were down and all areas of CSRD had a decrease in taxation from Draft 1.

Public consultation:

No questions or comments from public.

CAO advised the Committee that the 2025 budget process would take place earlier during a Committee of the Whole meeting in the fall of 2024.

The Board acknowledges that there have been recent consultations with more than 650 representatives of stakeholder groups and we value the time and consideration invested in these discussions. The Board appreciates the additional time afforded by pausing the process; this pause will allow for further engagement with community and stakeholder groups who represent British Columbians.

The Board supports the community consultation process that is being conducted by the Provincial Government and believes stakeholder engagement is extremely important on sensitive issues such Land Act legislation. Our opinion is that the final product will benefit from being shaped by a range of perspectives and by moving forward together.
