SHORT SUMMARY:		
At the July 19, 2018 Board meeting, the Board endorsed a resolution for application to the BC Rura Dividend Fund Program in the amount of \$500,000 under the Partnerships funding stream in a regiona partnership for a Project Manager position and preliminary design soft costs related to the development of the Rails to Trails project from Sicamous to Armstrong.

BACKGROUND:

In December 2017, the CSRD and the North Okanagan Regional District acquired the abandoned rail corridor from Sicamous to Armstrong. The BC Rural Dividend Fund grant would allow for preliminary development of the trail network. Matching funds of \$336,000 are required for this application. It is proposed that one-half of the matching funds (\$168,000) would come from the Sicamous/Area E EOF funds and the remaining one-half of the matching funds would come from the District of Sicamous. These matching funds can be contributed over two years. Additionally, donations and in-kind contributions could be used as part of the matching funds, which would reduce the required funds, however, the commitment is required in advance of other types of potential funding.

POLICY:

This request meets the criteria for support in relation to CSRD Policy *F-29, BC Hydro Payments -in-Lieu of Taxes* funding assistance to stimulate economic development within the Sicamous/Area E area.

FINANCIAL:

The approximate balance of the Sicamous/Area E EOF (less commitments) as at July 31, 2018 is \$360,000. This balance includes the 2018 distribution that was received in July 2018.

COMMUNICATIONS:

All funding partners and owners of the Rail Trail Corridor will be advised of the Board's decision.

DESIRED OUTCOMES:

That the Board endorse the recommendation.
