

## **BYLAW NO. 5775**

## A bylaw to amend Shuswap Economic Development Service Bylaw No.5268

WHEREAS Bylaw No. 5775, cited as "Shuswap Economic Development Service Bylaw No. 5268" establishes an extended service area for the purpose of providing economic development;

AND WHEREAS the Board deems it desirable to amend Bylaw No. 5268 to remove the District of Sicamous as a participating area in the service;

AND WHEREAS the Directors for Electoral Areas 'C,'D,' 'E,' and 'F' have consented, in writing, to have the District of Sicamous removed as a participant from this service;

NOW THEREFORE the Regional Board of the Columbia Shuswap Regional District, in open meeting assembled, HEREBY ENACTS as follows:

- 1. Sections 1, 2 and 3 of Bylaw No. 5268 are amended by deleting the words "and the District of Sicamous" from Section 1, Section 2 and Section 3.
- 2. This bylaw may be cited as "Economic Development (Electoral Areas 'C', 'D', 'E' and 'F') Service Amendment Bylaw No. 5775."
- 3. This bylaw will come into effect on December 31, 2018.
