COLUMBIA SHUSWAP REGIONAL DISTRICT

BYLAW NO. 5783

A bylaw to establish the Scotch Creek Water Upgrade Service Area within Electoral Area F

WHEREAS a regional district may, by bylaw, establish a service under the provisions of the Local Government Act;

AND WHEREAS the Board of the Columbia Shuswap Regional District wishes to establish a service area for the purpose of providing upgrades to the Saratoga Waterworks water distribution system and to carry out a watermain extension to allow for connection of the Scotch Creek community within Electoral Area F;

AND WHEREAS the property owners within the proposed service area have petitioned the Columbia Shuswap Regional District to establish a service area for the purpose of connection to the Saratoga Waterworks water system;

AND WHEREAS the Director for Electoral Area F has consented, in writing, to the adoption of this bylaw;

NOW THEREFORE in open meeting assembled, the Board of Directors of the Columbia Shuswap Regional District enacts as follows:

SERVICE DESCRIPTION

1. To establish a service area for the purpose of providing upgrades to the Saratoga Waterworks water distribution system and to carry out a watermain extension to allow for connection of the Scotch Creek community within Electoral Area F.

BOUNDARIES OF THE SERVICE AREA

2. The service area boundaries established by this bylaw are shown outlined on Schedule A attached hereto and forming part of this bylaw.

PARTICIPATING AREA

3. The participating area in the named service is Electoral Area F.

REQUISITION

4. The maximum amount of money that may be requisitioned for the service provided under Section 1 of this bylaw will be \$200,000 annually.

COST RECOVERY

- 5. The annual operating and debt servicing costs shall be recovered by one or more of the following:
 - a) The requisition of money to be collected by a parcel tax;
 - b) The imposition of fees and other charges that may be fixed by separate bylaw for the purpose of recovering these costs;
 - c) Revenues received by way of agreement, enterprise, gift, grant or otherwise.

EFFECTIVE DATE


6. This Bylaw will come into effect upon adoption.
