### PREAMBLE:

The EOF were created specifically as a means of compensating for the loss of economic opportunities on those lands affected by the dams and reservoirs and the resultant economic impacts to the affected communities. As such, the EOF are to provide funding assistance for projects deemed by the participating members and ratified by the Corporate Board to be worthy of support in an effort to stimulate economic development within the impact areas.

The EOF shall not be used as grant-in-aid funding.

## **Attachment to Application for Economic Opportunity Funds**

It is the purpose of this application to secure \$10,000 representing 25% of the total cost of the 2018 annual Summer Kicks outdoor concert series that has for the past decade featured a minimum of eight outdoor concerts in Golden's Spirit Square, free for the residents of Golden and Area 'A'.

Up to and including 2017, the CSRD Area 'A' contribution was begotten through the Area Director's Grant in Aid program. Upon the recommendation of the *Partnered Services Delivery Review Committee* of Council (of which the Area Director was a member and the CSRD CAO an advisor) to both the Town of Golden Council and the CSRD it was determined that the annual Summer Kicks budget of \$40,000 would be split 75/25 between the two local governments and merged with the traditional cultural services requisition of \$120,000, split 50/50.

The recommendation was as follows:

### **Cultural Services**

***THAT Committee RECOMMENDS that Council and the CSRD each RETURN to a tax funded model for cultural services effective January 1st, 2018;***

***AND THAT the Cultural Services Contract terms and Summer Kicks programs BE MERGED into a singular Terms of Reference for overall annual Cultural Services;***

***AND FURTHER THAT the funding split for these services be designated as 50/50 for traditional cultural services and 75% (TOG)/25% (CSRD) for the summer outdoor concert series.***

This would then result in the CSRD issuing payment of \$70,000 per annum to accompany the Town of Golden's own requisition of \$90,000 toward annual cultural services for the greater community.

It appears this new arrangement for Summer Kicks was not effectively communicated to the CSRD administration and did not materialize in the 2018 August payment to the town; therefore, town staff are applying to the EOF to secure the 25% budget amount with the understanding that the CSRD requisition and issuance amount will be corrected for 2019.
