BACKGROUND:

Members of the Board have previously received a number of handouts related to the 2019 Five Year Financial Plan during the budget deliberations at the Committee of the Whole meetings. There have been six minor adjustments made to the 2019 Five Year Financial Plan since the February 27, 2019 Committee of the Whole meeting which are identified on the summary of changes attached.

POLICY:

Section 374(1) of the Local Government Act states that a Regional District must have a Five Year Financial Plan adopted annually, by bylaw, by March 31.

FINANCIAL:

The 2019 Five Year Financial Plan is presented to the Board on a high level as recommended by the Local Government Division of the Ministry of Municipal Affairs and Housing. A copy of the detailed document does not form part of the Bylaw, but rather demonstrates how the budget was built by line item. The budget in Schedule A will become the basis of comparison for financial reporting in the year-end Financial Statements. Funding is detailed by source, while expenses for each service are detailed by Function.

IMPLEMENTATION:

The Five Year Financial Plan will be implemented immediately upon adoption.

COMMUNICATIONS:

The approved 2019 Five Year Financial Plan Bylaw No. 5794 will be distributed to member municipalities and the Ministry of Municipal Affairs and Housing. It will also be published on the CSRD website.

DESIRED OUTCOMES:

The Board approve and adopt the 2019 Five Year Financial Plan Bylaw No. 5794.
