Pursuant to Section 269 of the *Local Government Act*, the Regional Board of the Columbia Shuswap Regional District is proposing to seek approval of the electors by alternative approval process in accordance with Section 86 of the *Community Charter*.

By completing this elector response form, I am certifying that I am **OPPOSED** to the adoption of both "Centennial Field Community Park Service Establishment Bylaw No. 5800, 2019" that establishes a service to allow the CSR D to acquire, develop, manage and operate a regional park, and "Centennial Field Community Park Loan Authorization Bylaw No. 5801, 2019" authorizing borrowing for the purpose of acquiring the park land properties.

Pursuant to the Local Government Act and the Community Charter, I certify that I meet the following requirements:

- 18 years of age or older;
- Canadian citizen;
- resident of BC for at least 6 months immediately preceding August 23, 2019;
- resident of OR registered owner of real property within Electoral Area C of the Columbia Shuswap Regional District for at least 30 days immediately prior to August 23, 2019; and,
- not otherwise disqualified by law from voting.

For this elector response form to be counted, it **MUST** be complete and received by the Columbia Shuswap Regional District (CSRD) Deputy/Corporate Officer no later than 4:00 PM on Wednesday, October 2, 2019. **Postmarks will not be accepted as the date of submission.**

The CSRD Board may proceed with the adoption of Bylaw No. 5800, 2019 and Bylaw No. 5801, 2019 unless 671 electors sign and submit a completed copy of this Elector Response Form to the Deputy/Corporate Officer, Columbia Shuswap Regional District office by the deadline of **4:00 PM on Wednesday, October 2, 2019.**

## ELECTOR QUALIFICATIONS

In order to sign an elector response form, a person **must** either be a resident of Electoral Area C,

**OR**

be a non-resident property elector who owns property in Electoral Area C **AND** lives elsewhere in BC. Qualifications are defined in the *Local Government Act*:

**Resident Electors** are individuals who are entitled to sign an elector response form during this Alternative Approval Process are those **living within** either Electoral Area C **AND** meeting the following qualifications:

1. Age 18 or older; and
2. A Canadian Citizen; and
3. A resident of British Columbia for at least 6 months; and
4. A resident of Electoral Area C for at least 30 days; and
5. Not disqualified by the *Local Government Act* or any other enactment from voting.

**Non-Resident Property Electors** are individuals who are entitled to sign an elector response form during this Alternative Approval Process are those **owning property within** Electoral Area C **AND** meeting the following qualifications:

1. Not a resident elector; and
2. Age 18 or older; and
3. A Canadian Citizen; and
4. **A resident of British Columbia for at least 6 months;** and
5. A person who is the registered owner of real property in Electoral Area C for at least 30 days; and
6. Not disqualified by the *Local Government Act* or any other enactment from voting; and
7. Not holding the property in trust for a corporation or another trust.

A person may only sign as a non-resident elector for one parcel within the area to which this Alternative Approval Process applies regardless of the number of parcels they have interest in.

**Where there is more than one person registered as the owner of real property, either as joint tenants or tenants in common, only one of those persons may sign this Elector Response Form with the written consent of the majority of the other owners.**

Please note: Corporations or businesses are not entitled to sign elector response forms
