#### BYLAW NO. 5804, 2019

#### A bylaw to amend Blind Bay Street Lighting Service Area Bylaw No. 5704

WHEREAS a service area has been established by the Columbia Shuswap Regional District by Bylaw No. 5704, cited as Blind Bay Street Light Service Area Bylaw No. 5704, for the purpose of providing street lighting to the Blind Bay area within Electoral Area C;

AND WHEREAS the Board deems it desirable to include additional parcels of land into the street lighting service area;

AND WHEREAS the Director for Electoral Area C has consented, in writing, to the adoption of this bylaw;

NOW THEREFORE in open meeting assembled, the Board of Directors of the Columbia Shuswap Regional District enacts as follows:

#### BOUNDARY

1. The boundaries of the Blind Bay Street Lighting Local Service Area as established by Blind Bay Street Lighting Local Service Area Bylaw No. 5704 are hereby extended to include the lands outlined and described in Schedule B, which is attached hereto and forms part of this bylaw.

2. Schedule A of Blind Bay Street Lighting Local Service Area Bylaw No. 5704 is hereby deleted and replaced by Schedule A attached hereto and forming part of this bylaw.

#### **EFFECTIVE DATE**

3. This Bylaw will come into effect upon adoption.


