Chair and Directors 6140 70 16 TO: File No: **SUBJECT:** Bristow Road Boat Launch – Crown Foreshore Tenure Application **DESCRIPTION:** Report from Ryan Nitchie, Team Leader, Community Services dated January 8, 2020. RECOMMENDATION THAT: the Board empower the authorized signatories to acquire a #1: Licence of Occupation from the Province of BC for the term of 20 years over the land described as all that unsurveyed Crown foreshore being part of the bed of Shuswap Lake and fronting on Lots 2 and 3, Section 9, Township 23, Range 10, West of the 6th Meridian, Kamloops Division Yale District Plan 4002, containing 0.22 hectares, more or less, for boat launch, dock and dry hydrant purposes, this 16th day of January, 2020. SHORT SUMMARY: The CSRD purchased a 1.08 acre property located at 1946 Bristow Road, Celista in Electoral Area F in 2017. Staff is currently planning the development of a boat launch and required amenities for the property. The CSRD has applied for a foreshore tenure licence from the Ministry of Forests, Lands and Natural Resource Operations and Rural Development (MFLRNORD for the property. In order to complete the application process for a license, a resolution from the Board is required that confirms the Board's support. BACKGROUND:

The Bristow Road property was purchased by the CSRD in November 2017 for the purposes of creating a public boat launch and park facility. The CSRD has applied for a foreshore licence over a portion of Shuswap Lake adjacent to the property in order to facilitate a dock, boat launch and dry hydrant. A resolution was previously passed by the Board on February 15, 2018 supporting the application. The MFLNRORD now requires a specific resolution that confirms the CSRD's support of the licence over a 20 year period.
