Re: Phase 3, Mt.7 Community Trail (Re) Development Project – “Schacher Trail”

The Golden Cycling Club (GCC) is requesting funding support towards completing the final phase (phase 3) of the MT7 Community Trail (Re) development Project “Schacher Trail”.

GCC is requesting support in the amount of \$25,000 through the Economic Opportunity Fund.

We hope to use this funding to reach our budget for this project:

- **CBT- CIP/AAP - \$40,000**
- **CBT – Recreation Infrastructure Grant - \$40,000**
- **CVCU - \$5,000**
- **Rural Dividends - \$90,000**

The overall budget for Phase 3 is budgeted at \$200,000, based on creating 10km's of Blue rated climbing & descending trail, as defined by the IMBA.

As we have proved with the help of a variety of funding sources in the 2016 building season the GCC has delivered major additions to the local trail infrastructure in the lower mt7 area including:

- **7 – UP**
- **Bush Party**
- **Berminator**
- **Rodeo Drive**
- **Major improvements to the Rotary Trail network.**
- **A 60' timber bridge overpass at the Selkirk Slacker/Snake Hill intersection that allowed us to successfully host the inaugural G24 event.**
- **Phase Two of the Schacher trail was completed**
- **Foundation for the Gazebo was poured and placed ready to receive the Timber Frame Gazebo that will be installed at the launch site spring 2017.**

1. The Schacher Trail

This part of our project has been split into three phases spread over three building seasons.

- **Phase one (completed fall 2015):**

This phase consists of 1 km of trail that runs through private land, from the 2.5km to the 3.5km mark on the MT7 forestry road. The GCC established a Memorandum of Understanding with the private landowner that a small portion of the trail traverses across, and undertook the work with funds raised from cash donations to the Schacher fund managed by the GCC and donations in kind of machinery and labour.

- **Phase two (completed fall 2016):**

This phase consists of 4 km of new trail development connecting from 3.5km to the 5km mark of the MT7 forestry road.

- **Phase three (Scheduled Summer 2017):**

This phase consists of the final 10km of new trail development connecting from the 5km mark on MT7 road to the launch site.

This new biking and hiking trail on Mt. 7 was named “the Schacher trail”, in memory of local rider Sean Schacher who passed away July 2, 2014. This trail will be designed to be as accessible as possible to a wide variety of user levels, varying from beginner to intermediate in difficulty rating for both climbing and descending. In addition, a 16’x24’ covered community shelter/Gazebo will be constructed at the current hanglider/paraglider launch site, which will locate the trails terminus on the upper slopes of MT7.

The Golden Cycling Club is a not-for-profit organization based in Golden, BC. Since inception in 2007 the Golden Cycling Club has been responsible for the construction and maintenance of more than 100 km of trail in Golden and Area A. The club has successfully advocated for the construction and maintenance of trails, provided youth and adult programs, and advocated for all forms of cycling in the community. With more than 550 members, and many more trail users (nearly impossible to measure as trail use is free) the Golden Cycling Club is a huge part of the community and a major tourism driver for the area.
