Re: the PL20210000112(#93192 near Nicholson).

Through a preliminary analysis ALIB has identified some concerns which include:

x4 known ALIB cultural heritage sites (these do not include archaeology but are specific to ALIB) found intersecting and to within 5 km, including Indigenous heritage trails and subsistence. It has potential for archaeology and is in the Rockies Park Ranges grizzly population unit and the Columbia River watershed (fish habitat).

Adams Lake holds constitutionally protected Aboriginal rights including title throughout the entirety of its territory. Members of Adams Lake continue to exercise their Aboriginal rights as their ancestors have done for generations, including hunting, trapping, gathering and fishing, along with rights associated with spiritual and cultural traditions which are practiced in accordance with Secwepemc customs, laws and governance structures.

While ALIB does not have any immediate concerns, I was unable to access the posted (links) documents so do not know what the purpose of taking the lands out of the ALR is. It would appear that there are gravel pits there. Is this in order for them to excavate more gravel out of the ALR? Please attach (messaging) at least one document that discusses the purpose of this exclusion so that I may make a fully informed decision.
