# 5.1.1 BC Timber Sales - Wiseman Creek Harvesting Operations Update (May 31, 2022

Letter from Grace Chomitz, Planning Forester, BC Timber Sales advising the CSRD plans for salvage harvesting in the Sicamous and Wiseman Creek Community Watersheds remain unchanged.

#### Discussion:

Director Martin was disappointed with the response from BCTS and the lack of understanding of regional districts versus municipalities. She said high volumes of rain had resulted in multiple evacuation alerts for residents who reside in the mobile home park as there was real risk of a potential landslide.

Team Leader, Protective Services (TLPS) said BCTS had stated it was necessary to correct various legacy mistakes have been made in the watershed due to logging in the 50's and onward. The TLPS had asked BCTS why the harvesting needed to happen, could they simply not correct the mistakes that were made with out removing the timber; which according to the CSRD geotechnical engineers was holding the slope together. It was suspected that profits from the salvage harvested timber would be used to offset the direct costs of the mitigative work.

Directors agreed there was a difference in scientific opinion between those consultants hired by BCTS and CSRD. Overall, the Directors were displeased by the direction taken by BCTS to continue with the salvage harvesting. Directors thought that it wise to err on the side of caution if there could be a risk to public safety.

#### Discussion:

Team Leader, Environmental Health Services (TLEHS) advised that the intention of disallowing double axel vehicles or trailers was to restrict commercial access to free land clearing disposal for commercial businesses. He also advised that due to capacity restrictions at the transfer stations prior to the bylaw change there were multiple closures as the bins filled extremely quickly from large loads what were taken to the smaller locations whereas the landfill can accommodate larger yard waste loads.

TLEHS informed the Board that a Waste Management Plan (WMP) review would begin in 2023; this process includes public engagement, giving residents the opportunity to weigh in on a host of options and is anticipate taking 2 years to complete. TLEHS has discussed coordinating with FireSmart to offer yard waste drop off solutions for residents starting in 2023.
