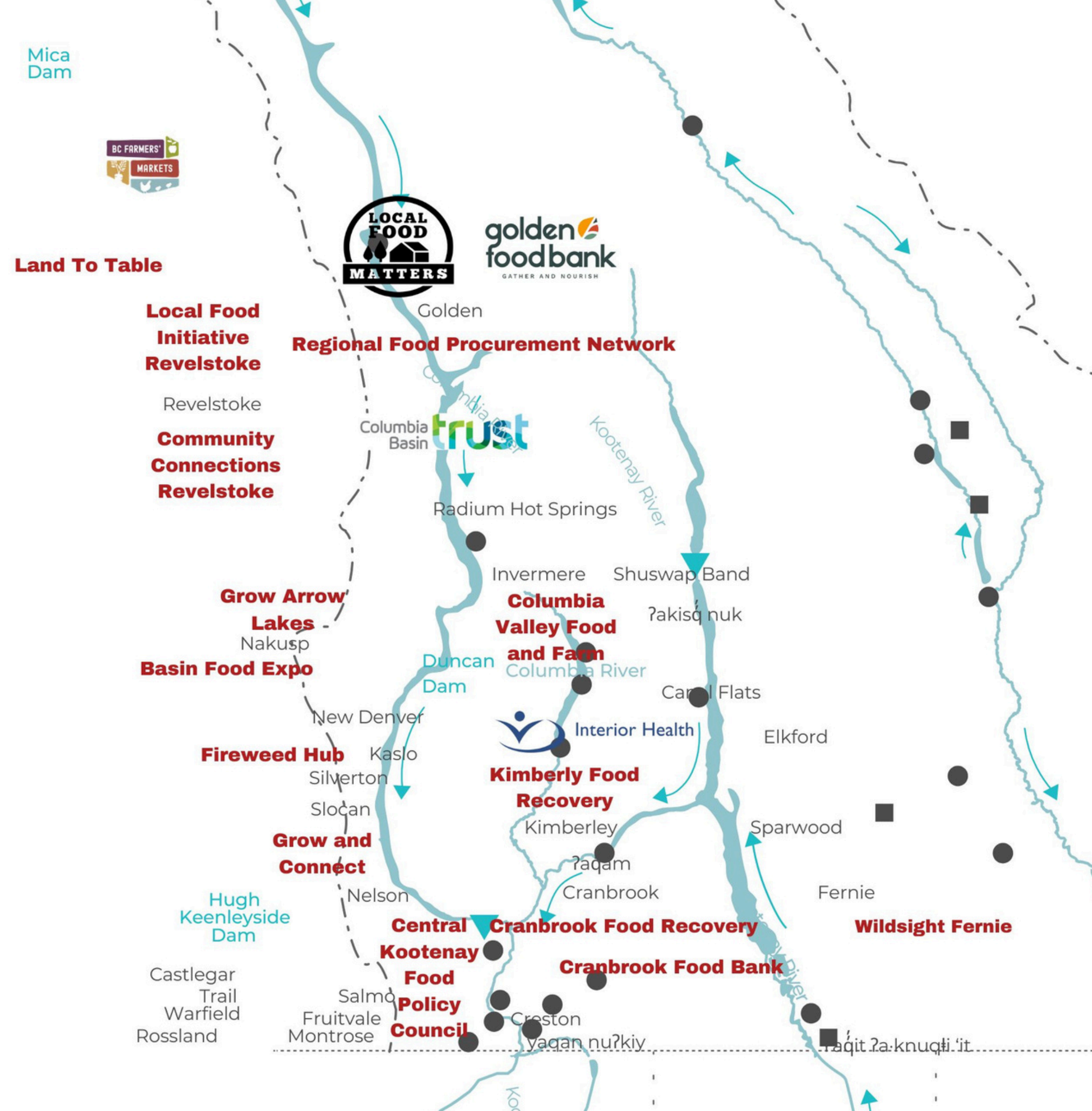
Compost Feasibility Study

- examined feasibility of a commercial sector compost collection program
- engaged major waste producers to determine barriers
- Convened a Working Group of major partners
- Produced a Compost Project Report
- pending update to CSRD Waste Management Plan including the future of the Golden Landfill site
- recommendation to explore partnership with RDEK Invermere facility for Golden collection program



Growing the Local Food Network

- building relationships
- partnering and collaborating
- regional solutions to food security





TREASURERS REPORT

- core funding from local government
- sponsorships from the community
- grant funding to support program start up
- market revenue increased representing a growth in vendor attendance
- total income of \$106,524 up from \$12,765 in 2023
- investment in market infrastructure
- new office space
- investment in gleaning equipment and storage
- building administrative and operational capacity
- investment into regional collaborations
- deferred income of \$42,437 carrying us into 2025

PROPOSED BY-LAW AMMENDMENTS

6.4 At each annual general meeting, the voting members entitled to vote for the election or appointment of directors must elect or appoint the Board. Voting must be by a show of hands, an oral vote or another method that adequately discloses the intention of the voting members. The chair of a general meeting must announce the outcome of each vote and that outcome must be recorded in the minutes of the meeting.

6.5 Directors may be elected for terms that are either one (1) or two (2) years

6.6 The Board may, at any time, appoint a member as a director to fill a vacancy that arises on the Board as a result of the resignation, death, or incapacity of a director during the director's term of office.

6.7 Directors may serve a maximum of 10 years. A person who has served ten consecutive years may be appointed again after 1 year has lapsed

6.8 The Board may remove a Director from Office with a 2/3 majority vote from the Directors

6.9 The quorum for the transaction of business at a Directors meeting is the majority of the Directors.

- Positioning Golden as a user and contributor within the regional food system as a key component of our local food resiliency.
- Launching a healthy local food meal in the schools.
- Tracking and solutioning the key gap of cold storage.
- Addressing longer-term financial and HR sustainability needs.
- Exploring revenue generating ideas

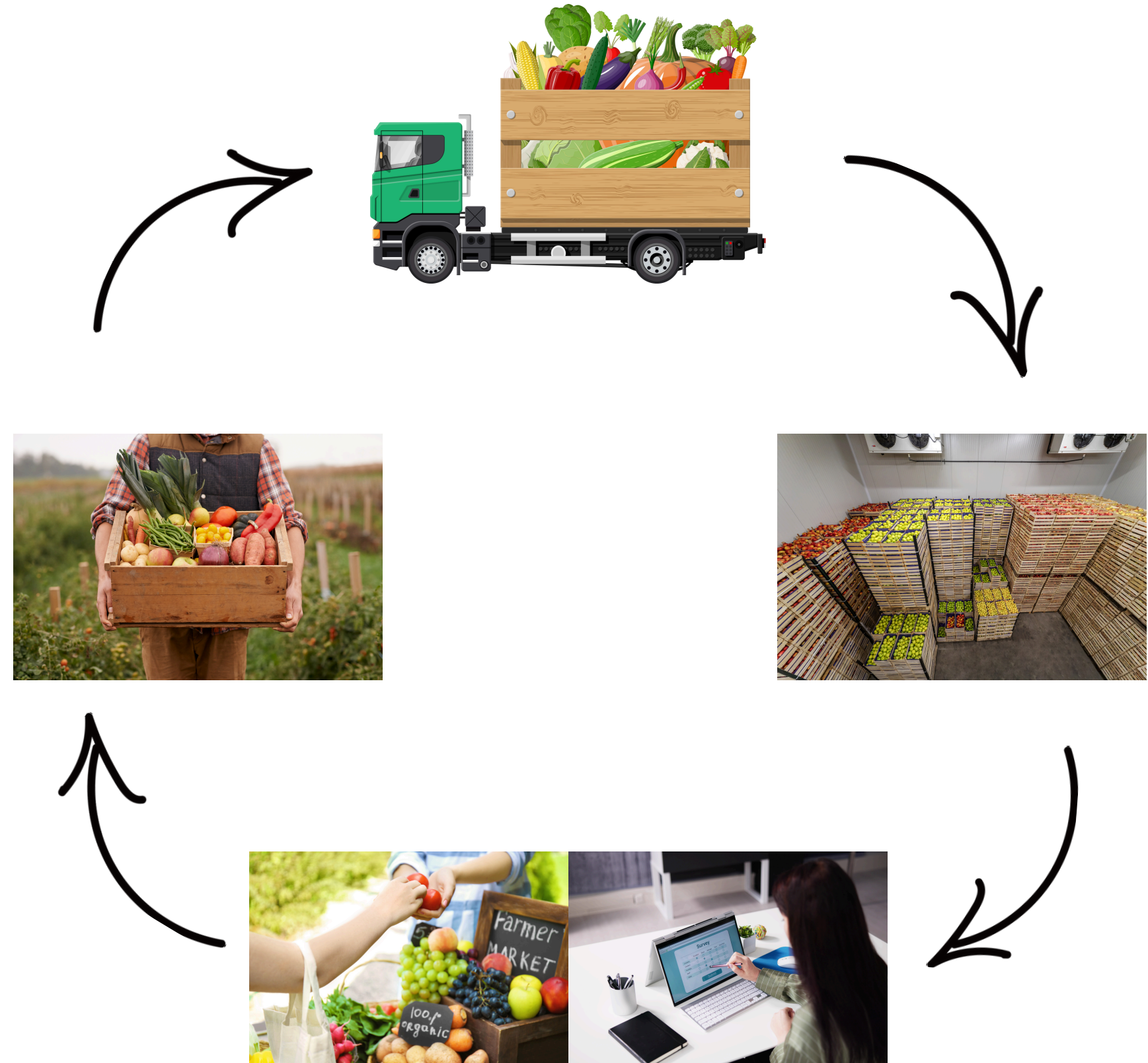
