BACKGROUND:

Development pressure on provincial Crown land continues to increase within the Columbia Shuswap Regional District (CSRD) and elsewhere within the Province. Crown Land Tenure for licences of occupation, leases, permits, etc., are granted by the Province in the CSRD for a variety of land use sectors including but not limited to: industry (forestry, mining, aggregate quarries); recreation/tourism (front and backcountry tourism, motorized and non-motorized uses); utilities (independent power projects); telecommunication sites; roadways; and private moorage. In many cases when tenure is granted, there is an overlap with other pre-existing tenures and land use sectors. This overlap and high saturation of Crown land tenures is especially notable in Electoral Areas A, B, E and F of the CSRD, as shown on the attached CSRD Crown Land Tenure map.

While one particular development activity may have a minimal impact to the land base, it is the cumulative impact of many activities in a finite land base that may compound and cause significant harm to the environment. Strategic Land and Resource Management Plans (LRMPs), which were implemented at least 15 or more years ago, provided a certain level of direction in managing these uses, but either do not exist Province-wide or are now too outdated to adequately address the extent and intensity of current development activity on Crown land.

POLICY:

Several CSRD Official Community Plans (OCPs) contain policy statements which advocate improved environment stewardship and planning on Crown land:

Electoral Area B OCP Bylaw no. 850:

- 3.2.3 Plan for and protect wildlife corridors, habitat of threatened and endangered species and ecosystem connectivity in advance of expansion of settlement areas or tenures.
- 7.3.4 Encourage the Province of B.C. to undertake a backcountry recreation planning process.
- 12.2.2 Preserve and enhance the ecological systems and diversity of the Regional District.

Electoral Area C OCP Bylaw no. 725:

Section 6 - Although much of the South Shuswap will remain in its natural state, in areas where development does take place there is a need to protect sensitive ecosystems, including shoreline and aquatic environments, wetlands and wildlife habitat.

Electoral Area F OCP Bylaw no. 830:

Section 2 - Although much of the North Shuswap remains in its natural state, there is a need to protect sensitive ecosystems, and ensure that when development occurs, it fully takes into account the natural environment.

FINANCIAL:

There are no financial implications to the CSRD with regard to the proposed resolution.

KEY ISSUES/CONCEPTS:

The recent mandate letter (attached to this report) from BC Premier, John Horgan, to Minister Donaldson (Ministry of Forests, Lands, Natural Resource Operations and Rural Development, dated July

18, 2017), signals that the Province is aiming to "modernize land-use planning and sustainably manage B.C.'s ecosystems, rivers, lakes, watersheds, forests and old growth."

This renewed interest in Crown land planning was also echoed by John Hawkings, Executive Director, Recreation Sites and Trails BC (RSTBC), at the November 29, 2017 Shuswap Trails Roundtable meeting in Chase, in which several CSRD Electoral Area Directors and staff were present.

Subsequent to this meeting, Electoral Area E Director Rhona Martin requested that a resolution be prepared for consideration by the CSRD Board of Directors and submitted to SILGA to urge the provincial government to follow through with its statements about modernizing land use planning on Crown land, focusing on stakeholder collaboration, to develop long and short term strategies to manage B.C.'s Crown land.

SILGA and UBCM have significant influence and will hopefully compel the Province to take a leadership role and immediately provide sufficient funding and resources to enable effective, community-based, collaborative land use planning for Crown land which includes First Nations, local governments, provincial government agencies, industry sectors, interest groups, and local residents.

The Shuswap Watershed Council and Shuswap Trails Roundtable are two local initiatives that showcase how collaborative planning is succeeding in the Shuswap and serve as models that may be replicated elsewhere in the province.

IMPLEMENTATION:

Subject to endorsement by the Board, the resolution will be sent to SILGA for consideration of endorsement at their 2018 Annual General Meeting. Resolutions endorsed at SILGA are submitted automatically to UBCM for consideration at the 2018 UBCM Convention.

COMMUNICATIONS:

In January 2018, Director Rhona Martin requested Development Services staff draft a resolution addressing Crown land use management planning to be considered by SILGA. If the Board endorses the staff recommendation, staff will forward the resolution and a cover letter to SILGA before the February 23, 2018 submission deadline.

DESIRED OUTCOMES:

That the Board endorse the staff recommendation.
