COMPLETE OVERVIEW OF POSITIONS AFFECTING SWANSEA POINT FOR YOUR PERUSAL.

1. KLOHN CRIPPEN REPORT.....RISK TO US.

We have the 15 reports that were commissioned by the C.S.R.D., M.L.A.s, etc., all of which show the danger to us. None seemed to be taken notice of and it was disheartening as it cost so much to the tax payers in our area.

Our **finale** was the June 24th, 2003 report by Klohn Crippen, not obtained by us until 2013. It was the report of reports and shows on an **extreme level of Risk** to us after reading just the first few pages of the summary by the Engineers. The full report is 132 pages long and is available from us at any time you request it.

It describes the danger to us living in this area, should logging begin again above us. Page (vi.) is marked with a **bright pink post it**. For your attention.

We have enclosed the first seven pages of this report (engineers on Risk to Probability of Death) for your perusal.

2. A DIALOGUE AFTER THE DEMISE OF THE FOREST PRACTICES CODE AS WE KNEW IT AND HOW THE GUIDELINES FOR FOREST STEWARDSHIP PLANS SHOULD BEGIN....LAPSED TIME 2006 TO 2016.

- A. Within the dialogue of Forestry Personnel in positions of authority, it is established that a majority of The Forest Service's Plan files will reach their maturity within two year.
- B. The Chief Forester suggests that the overall plan is failing and if the forest industry and government do not come to a satisfactory improvement the province will consider whether more prescriptive actions should be taken.
- C. As it is written, should we be asking for Government, Industry and Us to design the plan together? As perhaps a collaborative effort? **Large Report Enclosed.**

In conclusion we would ask that you read these two packages of information on and about logging and our community. This is just a snippet of the plethora of information we have researched on the subject of logging practices, clear cuts, cut blocks, watersheds, aquifers, wild creeks, debris torrents/flows, geotechnical reports, sediment coring risk management studies, Landslide Risk after Logging and Alluvial Fans.

Our fervent request to you is that you take the time to work with us and all of the endangered areas around us and ask for a Moratorium on Logging Practices in these very steep inclines and crown wild creeks in order to make all of your Columbia Shuswap Regional District Residents Safe.

Further to our research, all requests for moratoriums on logging in a specific area must be put before the Legislative Assembly and cabinet. Therefore all government entities must be corresponded with. Thank you for your time.
